

Privacy Policy

Introduction

Stuck Coaching, Inc. ("Stuck Coaching") respects your privacy and Stuck Coaching is committed to protecting it through Stuck Coaching's compliance with this policy.

This Website and Platform Privacy Policy (the "Privacy Policy") describes what information Stuck Coaching may collect from you or that you may share with Stuck Coaching when you access or use the website located at www.getunstuck.com (the "Website") or the Stuck Coaching platform ("Platform"), and how Stuck Coaching uses such information.

What Does This Policy Apply To?

This Privacy Policy applies only to the Website and Platform, which are owned and controlled by Stuck Coaching. By accessing the Website and/or Platform, you acknowledge and fully agree to the terms and conditions of this Privacy Policy and freely consent to the information collection and use practices described in this Privacy Policy.

This Privacy Policy does not apply to any other website or platform, including websites that have hypertext links to the Website or third-party websites that the Website links to. Accordingly, this Privacy Policy does not apply to, and Stuck Coaching is not responsible for, the practices of any third party, affiliate or business partner that Stuck Coaching does not own or control.

Collection and Use of Non-Personal Information

If you browse the Website or use the Platform without submitting any information, you do so anonymously. Stuck Coaching does log your IP address (the internet address of your computer) to determine which parts of the Website and/or Platform you visit and how long you spend there. Stuck Coaching does not link your IP address to anything personally identifiable; however, Stuck Coaching does track the state and/or country you are accessing the internet from, the date and time you visited and the type of computer, operating system and web browser you are using. Your browser supplies us with this information.

Stuck Coaching uses this information from its server logs to learn more about Stuck Coaching 's users as a group, not about you as an individual. The information helps Stuck Coaching identify overall usage patterns and trends on the Website and Platform, administer its Website and Platform, improve content and gather broad demographic information for aggregate use. Stuck Coaching will not sell personally identifiable information to third parties without your permission.

Collection and Use of Personally Identifiable Information

The Website includes a form that allows to you send messages to Stuck Coaching directly through the website. The Website and Platform may include additional forms, such as an information request form. When you complete these forms, Stuck Coaching will request some personal information, which may include name, address, e-mail address, telephone number or fax number, account number and other relevant information. You may also be asked to disclose personal information to allow Stuck Coaching to provide assistance and information to you. Stuck Coaching reserves the right to

use the e-mail address provided by you to inform you of other available products or services, or to contact you about your opinion of current products and services or potential new products and services that may be offered. You may opt-out of receiving future mailings from Stuck Coaching by following the procedures detailed in the Choice/Opt-out section located below or in any of the e-mail message(s) you may receive from Stuck Coaching.

By providing Stuck Coaching with such information, you give Stuck Coaching permission to contact you or use the information you provide for the specific purpose stated at the time you provide such information to Stuck Coaching. Stuck Coaching will not disclose personally identifiable information it collects from you to third parties without your permission except to the extent necessary including: to fulfill your request for services; to protect Stuck Coaching from liability; to respond to legal processes or comply with law; or in connection with a merger, acquisition or liquidation of Stuck Coaching.

Third Party Services

The Website and Platform may offer features and services that are administered or provided by third parties hired by Stuck Coaching, including website traffic analytics and surveys. To receive these services, you may be required to provide these third parties with personal information. All such services may be subject to additional or separate terms and conditions established by our third-party providers, including separate privacy policies, which may be different than this privacy policy.

Cookies

We may use cookies and other information to provide relevant interest-based advertising to you. Interest-based ads are ads presented to you based on your browsing behavior in order to provide you with ads more tailored to your interests. These interest-based ads may be presented to you while you are browsing our site or third-party sites not owned by us. Do Not Track

Stuck Coaching does not track its users over time and across third party websites to provide targeted advertising and therefore does not respond to Do Not Track (DNT) signals or mechanisms. DNT is a privacy preference that users can set in their web browsers. DNT is a simple way for users to inform websites that they do not want certain information to be collected. When you turn on DNT in your browser, we no longer have visibility to the sites you visit after you have left the Website.
